Installation of CCTV

Abi has had a meeting with NSDC regarding the CCTV in the town and there are plans to upgrade the cameras in the near future, this will include Kings Street, the Market Square and WMRG. NSDC have advised the council to wait until the upgrade before installing extra CCTV on the Market.

The supplier has also confirmed the proposed CCTV cameras are compliant with ICO and Police standard.

Costs are for the Skatepark and the Old Courthouse are below.

I suggest the Ground staff monitor the skatepark on a daily basis, as they do now and the Council review the need for CCTV at the September meeting after the official opening.

Legal requirement & obligations.

As a CCTV operator in public areas you would need to register (and a small fee i think) with the Information Commissioners Office: https://ico.org.uk/for-organisations/uk-gdpr-guidance-and-resources/cctv-and-video-surveillance/

That link has the guidance on whats needed and a quick self assessment guide. You'll need to include the CCTV details in your GDPR, have a written statement about the CCTV accessible to the public, have dedicated staff that deal with the CCTV operation/ requests and have signage at both sites stating you have CCTV and why!
